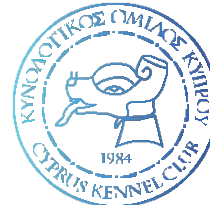

## Section 4: Sworn Declaration and Signature

The information kept in these records is bound by confidentiality and privacy and is protected as provided for by the General Data Protection Regulation – European Regulation 2016/679 (GDPR), which came into force on 25 May 2018. KOK may use the information provided through this Declaration in order to verify the accuracy of the information, prevent or detect offences, and protect the validity of its records and revenues.

You may be prosecuted and/or disciplined and/or criminally prosecuted under the law if you intentionally provide false details or misleading information.

KOK reserves the right not to proceed with any service you request if it determines, or in the opinion of its staff and/or the Board, that your application contains falsehoods or that the submitted documents are suspected to be altered, false, or incorrect. In such cases, fees are non-refundable, and by your signature you accept this condition as well as the regulations and terms governing the processing of requested services.

If falsification is discovered and/or applications are submitted with false details or that do not comply with KOK regulations, KOK reserves the right to penalize you even in your absence, since by signing this declaration, you accept this term and the internal regulations and constitution of KOK.

This information helps us verify the accuracy of the provided information and identify when our members or registered dog owners in our records or users fail to comply with the internal regulations, constitution of KOK, and/or decisions of the Board, which form part of the internal regulations of KOK.

By signing, we solemnly declare that we have been informed of and understood the full set of internal regulations of KOK and its constitution, all of which we accept unreservedly.
